State Shri Durgaji Homoeopathic Medical College and Hospital, Chandeshwar, Dist, Azamgarh-276001 - Uttar Pradesh For Admission in BHMS Course for the Session 2024-25 with Intake Capacity of 125 Seats (including 25 EWS). The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 28 and subsection (3) of the Act.

As per the observations made by MARB, the following information is provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below: -

- Teaching faculty: -
- a) 23 fulltime faculty for UG against the requirement of 28 fulltime teachers as per MSR 2013.
- b) In UG Department of Materia Medica Reader is not available against requirement of all 3 staff.
- c) No faculty in Department of Physiology including Biochemistry- No faculty.
- d) In UG Department of Pathology and Microbiology, Anatomy and Pharmacy- No lower faculty is available. Although both higher faculties are available in the department of Anatomy and Pharmacy.
- e) In UG Department of Surgery –Higher faculty is not available.
- f) In UG Department of Repertory- No higher faculty as professor is available against requirement of all 3 staff.
- g) Guest faculty shall be appointed.
- Hospital facilities: -
- a) OPD/IPD Case sheets shall be maintained with complete case history, analysis, evaluation and repertorisation and and made available in Medical Record Room for academic purpose of students and for follow up attendance of the patients.
- b) Bed Occupancy in % (P X 100 /275 X B) 4.22 % which is less than the requirement of 30 %.



- Miscellaneous:
- a) AEBAS is not enabled in college. The same may be enabled within a period of 30 days.

Considering the above observations, and facilities available, MARB has decided to issue Conditional Permission to State Shri Durgaji Homoeopathic Medical College and Hospital, Chandeshwar, Dist, Azamgarh-276001 - Uttar Pradesh For Admission in BHMS Course with Intake Capacity of 88 seats (including 18 seats EWS) reduced from 125 Seats (including 25 EWS) by reducing 37 seats for the academic Session 2024-25.

All the shortfalls observed in your College shall be rectified within a period of 30 days or before counselling initiates, whichever earlier and compliance report shall be submitted to the MARB, failing which the conditional permission issued will be cancelled without further notice.

All admissions shall be made by NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

As per section 24 (3) of NCH Act 2020, The College aggrieved by any decision of the Autonomous Board may prefer an appeal to the Commission against such decision within 30 days of the communication of such decision.
